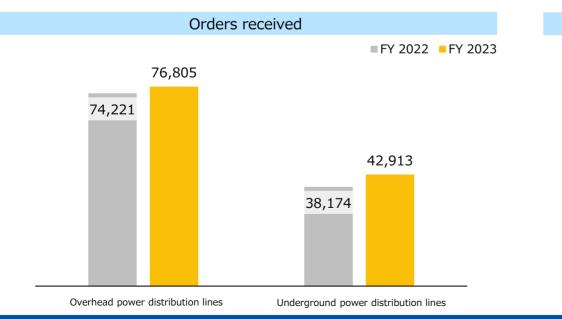

Net sales of completed construction contracts



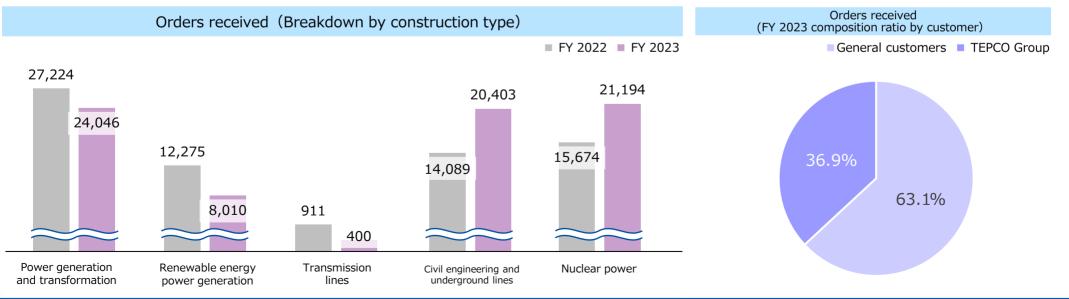
